The Minutes of the September meeting were approved.

Resignation

Sharon read out a letter from Cheryl Rikley informing the CoP of her upcoming retirement and her resignation from CoP. CoP agreed to give Cheryl's seat to her replacement, if Island Health is in agreement.

VIHA Video Status update

Virginia and Janice have edited the material. Signy's niece, Alida, will now go ahead and do a general rough draft, check the audio, insert music, change fonts, etc. There are some short clips and some longer items. Virginia hopes that the video will be done by Christmas.

Coordinator's Report

Lisa Marie submitted her monthly Coordinator Report to the CoP. It was suggested that going forward she includes Activities Planned for the upcoming 2 months rather than 1 month, and that this would also allow CoP members a chance to indicate where they might be able to participate or support her.

Terms of Reference

Courtney and Sharon have completed the finishing touches. CoP approved the finalized Terms of Reference by consensus.

Oceanside Collaborative Services Committee Update

Sue did not bring a report because the meeting was cancelled again this month. Next meeting is scheduled to be on October 30th.

Moving Forward: Evaluation

It was agreed that the Evaluation needs to reflect the Strategic Plan, where OHWN has come from, where we are now and where we are going.

Lisa Marie produced the Evaluation Summaries that were completed for the Child Wellness and Mental Health Action Groups. The Network Development Action Group is satisfied that these summaries meet the mandate for evaluation. The Network Development Group also created an Evaluation Summary for their group. We discussed the Child Wellness Evaluation in detail.

When we look at the Strategic Plan we have Goals, Objectives, Strategies and Measures of Success. Where are we as a CoP on the Strategic Plan? Does the Strategic Plan still reflect what we want to do as a network? Are we looking at the Collective Action piece?

Everything is currently focused on the Action Groups. We need to take the opportunity to look at the role of the CoP within the network. The CoP is the group of experts at the table.

Sharon pointed out that Oceanside has many networks, that tend to function as 'silos' within their networks. As a result there is much overlap. Initiatives are going on that could maybe have much greater impact if people were brought together.

Would bringing people together to integrate them and work together be a part of our role as OHWN? Should we refocus the time/use of CoP? Could OHWN be sitting on these different committees, or could representatives of these committees be at the OHWN table? Could we merge the talent and be more efficient by cutting down the overlap?

Lisa Marie and the Network Development Action Group did a draft Evaluation for CoP which shows that the Collective Action piece is missing. Newer members of CoP have not received training on Collective Impact. It would be helpful to have a presentation on Collective Impact at our next CoP meeting. Sharon and Lisa Marie met with Analisa of Island Health and discussed how OHWN could move forward, not starting over with our Strategic Plan but working on moving forward with it.

Sharon did ask that if anyone has frustrations or concerns to please voice them either at the table or to call Sharon and talk with her about them. It is important to be open, especially regarding the direction for CoP.
