**5. IRRIGATION UPGRADES ELIGIBLE COMPONENTS CHECKLIST:**

The below checklist contains automated irrigation system features that must be included to be eligible for the Irrigation Upgrades Rebate, complete the section(s) you were pre-approved for only. The installation of eligible irrigation components must be completed by an IIABC Certified irrigation contractor. See [www.irrigationbc.com](http://www.irrigationbc.com) for more information. *Note: do not complete this checklist if you only completed the Soil Improvements portion of the rebate program.*

CHECK TO MAKE SURE UPGRADED IRRIGATION COMPONENTS ARE ELIGIBLE:

**Smart Control Automatic Irrigation Controllers**

- Has a minimum 4 program capability.
- Can have multiple start times per day.
- Features a “seasonal adjustment” or “% adjust” option for programming relative water reductions.
- Can connect to a sensor (soil-moisture, weather, or rain) and alter program based on sensor data.
- Has a 365 day clock.

**Rain Sensor**

- Can connect to and be compatible with the installed automatic irrigation controller.
- Can automatically shut off irrigation system based on rain detection.

**Soil moisture Sensors**

- Can connect to and be compatible with the installed automatic irrigation controller.
- Can monitor soil conditions by measuring soil moisture at the root zone of plants.
- Can adjust irrigation programs or shut off the system based on detected soil moisture levels.

**Weather-Based Sensors**

- Can connect to and be compatible with the installed automatic irrigation controller.
- Can monitor weather conditions and calculate evapotranspiration.
- Can adjust irrigation programs or shut off the system based on collected weather data.

**Drip Irrigation Components** (note that soaker and weeper hoses, and "microspray" emitters are not eligible)

- Can deliver water at the plant root zone.
- Uses less than 20 gallons of water per hour at less than 25 PSI (pressure reducing valve installed).
- Include filtration to prevent clogging of emitters.

**Matched Precipitation Rotators**

- Distributes water evenly across varying spray radii and spray arcs.
