RDN Utility Work Machine RFP January 6, 2017

PROPOSAL FORM UTILITY WORK MACHINE PURCHASE - 2017

The purpose of this RFP is to obtain one (1) new or one (1) used Utility Work Machine (e.g. Bobcat Toolcat), for use at Church Road Transfer Station, located at 860 Church Road, Parksville, BC. A used Utility Work Machine or alternatives will be considered, if conditions as specified are met. The machine shall be suitable for transfer station operations such as floor sweeping, capable of various attachments for grounds maintenance and crew transport.

The machine should consist of a hard body cab with heat and A/C, diesel engine, self-dumping box, four-wheel drive, two-person seating, and attachments including a broom, utility fork and bucket. Pricing for a mower attachment is also requested.

PROPOSAL EVALUATION:

Evaluations will be based on "best value" for the RDN as solely determined by the selection committee. The selection committee will consider at least the following attributes and use their sole discretion in applying tradeoffs to determine best value:

- Any historical damage or mechanical defects on used model
- Delivery cost
- Duties/taxes
- Delivery date (anticipated no later than March 2017)
- Price

Short listed Suppliers may be asked to submit copies of original parts and maintenance records for the proposed used utility work machine, including worksheets, mechanics reports, work orders and parts/service invoices. This information may be used by the selection committee in the final determination of best value for the RDN.

INSTRUCTIONS FOR MAKING A SUBMISSION:

Suppliers must complete the attached template cover page (Appendix A) and specification table (Appendix B). It is preferred that alternate submissions are submitted as separate and distinct proposals.
