Dear Mr. Stanhope,

As you know, the obstetrics and perinatal unit component of the Phase II Redevelopment of the Nanaimo Regional General Hospital has undergone a significant revision that has resulted in an increase of an additional \$6,543.555 to the project. In our July 30, 2004 letter we asked Regional District of Nanaimo for its consideration of its 40% share in the amount of \$2,617,422. The Nanaimo Regional Hospital District approved its participation in the 40% share of the cost of this project and requested that other Regional Districts be asked to participate in this regional project.

We approached the Regional Hospital Districts of Alberni-Clayoquot, Comox-Strathcona, Cowichan Valley and Mount Waddington – all of which declined participation in the cost sharing. Their letters are attached for your information.

Therefore we are returning to you to request you reconsider your share of the cost of the obstetrical and perinatal unit component of Phase II of the Redevelopment of Nanaimo Regional General Hospital in the full amount of \$2,617,422.


Hello, Chuck

The Comox-Strathcona Regional Hospital District Board of Directors considered your cost-sharing request dated December 15, at their regular meeting held January 31, 2005.

Although supportive of the project the Comox-Strathcona Regional Hospital District Board has identified two major capital projects in the Comox Strathcona area as their priority. Both projects have been held in abeyance pending capital funding from the Province since 2001.

The Campbell River and District General Hospital is in desperate need of a major upgrade to address the outdated, seismically unstable in-patient units and renovations addressing the concerns of the Canadian Council on Health Service Accreditation with emergency department space. The estimated cost of this project is \$17 million dollars. St. Joseph's General Hospital requires an expansion of surgical facilities in increase surgical capacity and bring existing facilities up to 2004 standards. The estimated cost of this project is \$8 million dollars.

We therefore regret that the Comox-Strathcona Regional Hospital District is unable to approve the funding request for the Nanaimo Regional General Hospital, Phase II, Perinatal Component, at this time.
