

Dear Ms. Pearse:

Thank you for your correspondence of May 8, 2007, to the Honourable Lawrence Cannon, Minister of Transport, Infrastructure and Communities, regarding Island Scallops Limited's proposal to farm scallops off the east coast of Vancouver Island at Bowser. The Minister has asked me to reply on his behalf.

At the outset, I should inform you that Transport Canada's Navigable Waters Protection Division determined that this project will likely require an approval under section 5(1) of the *Navigable Waters Protection Act* (NWPA), which is included on the list of laws that prompt an environmental assessment under the *Canadian Environmental Assessment Act* (CEAA). This means that, prior to being in a position to provide any approvals for the project, Transport Canada must conduct an environmental assessment pursuant to the CEAA.

The department initiated the environmental assessment on September 13, 2006. The proposal requires a screening-level assessment, which is defined in the CEAA as an assessment that considers the environmental effects likely to result from a project. This includes the effects of accidents and malfunctions, the effects of the environment on the project, cumulative effects and the effect of any change on the environment on the current use of lands and resources for traditional purposes by aboriginal peoples.



A final decision as to the significance of any environmental effects has not yet been made. Transport Canada officials will be sure to inform you of the results once that decision has been reached.

I trust that the foregoing has addressed your concerns. Thank you for writing to the federal government.







REPORTS

8.1 Regional Parks Development Costs Charges Presentation

Mr. Osborne introduced David Reid, of the firm LANARC Consultants Ltd., the successful candidates retained to prepare a concept of the possible implementation of Development Cost Charges (DCCs) for RDN regional parks. If approved the RDN would be the first regional district to institute DCCs for regional parks. Mr. Osborne noted that he had met with the municipal administrators in this regard and they had requested the inclusion that capital improvements in regionally significant municipal parks be included in the report.

Mr. Reid reviewed the details of the process and the scenarios for development of the report on DCCs as outlined in the Regional Park Development Cost Charges Draft Report. He noted DCCs are fees that municipalities and regional districts choose to collect from new development to help pay the cost of off-site infrastructure services. With regard to parks they may be used for park land and new park facilities. Mr. Reid noted that DCCs vary between different municipalities and regional districts.

8.2 Englishman River Regional Park Management Plan Presentation

Mr. Reid briefly spoke to the process LANARC Consultants Ltd. will use to prepare the Englishman River Regional Park Management Plan. He noted the information brought forward in the Englishman River Regional Park Watershed Recovery Plan developed by LGL Limited and LANARC will be applied to the management plan.

Ms. Leigh Sifton, of LANARC Consultants Ltd., requested committee members assist the consultant team with their vision for the park by providing vision keywords and possible names for the park. Committee members brought forward numerous visions for the park and were requested to contact the consultants with their thoughts on the park throughout the process.

Mr. Osborne noted that management plan would be a long process and would continue through to March of 2008. To be of assistance to the consultant team, Mr. Osborne requested two members of the RPTAC Committee be appointed who would liaise with the consultants, staff and the Committee. Mr. J. Stanhope and Ms. S. Herle both volunteered their services.

8.3 Morden Colliery Trail Report

Mr. Osborne reviewed the Morden Colliery Trail Report for the Committee. The Morden Colliery Trail has been in existence since 1995 about the same time as the Regional Parks and Trail System was brought on board. Since that time it has been funded and managed under the Electoral Area 'A' Community Parks portfolio. The Morden Colliery Trail is a very historical trail which runs along the old Pacific Rail right of way to Coal Harbour. The 2005 Regional Parks and Trail Plan recognized the regional status of the Morden Colliery Trail and recommended that it officially transfer from the Electoral Area 'A' Community Park Function to the Regional Parks and Trails Function.

MOVED S. Herle, SECONDED M. Young, that the Morden Colliery Trail be officially classified as a Regional Trail.

8.4 Regional Parks Fire Cost Recovery Report

Mr. Osborne reported that at the present time the insurance held by the RDN does not cover the cost of fighting fires in regional parks. At the present time in case of a fire the protocol is to contact the Coastal Fire Centre who would then send equipment to suppress the fire and then they would bill the RDN after the fact for the service.

Mr. Osborne noted there were two possible approaches which the RDN could take to cover the cost of fighting fires. One possible approach would be to build a reserve fund to cover the cost of fire fighting. Then in the event of a fire the fund could be drawn upon to cover the costs.

The second approach would be the costs would be paid by the RDN and over a period of time those costs would be repaid through the Regional Parks and Trail function. In this approach the community is not taxed for something that may never happen.

Mr. Osborne noted he wanted the committee members to be aware of the situation and that both approaches would work. Unless direction was received from the Committee, Mr. Osborne stated that regional park fire protocol would remain as status quo. Staff were requested to investigate further with other regional districts on how they handle fire cost recovery and report back to the Committee.

8.5 Monthly Update of Community Parks and Regional Parks and Trails Projects April and May 2007

Mr. Osborne reviewed both April and May 2007 Community Parks and Regional Parks and Trails Projects Reports highlighting the following items:

- The RDN is exploring options for improved security at the Arboretum property in Cedar after about 300ft of chain link fence was stolen.
- Top Bridge Crossing project is in progress. No native artifacts have been found in the ground at the site other then the known petroglyphs.
- Englishman River Regional Park Management Plan is underway.
- During April two controlled burns removed the slash piles from Mt. Benson Regional Park.

MOVED J. Stanhope, SECONDED F. Van Eynde, that the Reports be received as presented.

NEW BUSINESS

9.1 Island Corridor Foundation

Mr. Osborne reviewed the Island Corridor Foundation Grants-in-Aid request in the amount of \$109,575. The monies requested are to be used to offset the taxes charged though the RDN to the Island Corridor itself. He noted the Island Corridor Foundation had made a presentation to the Board requesting the one time grant and that the Board had forwarded the request to the Regional Parks and Trail Committee for comment or discussion.

MOVED F. Van Eynde, SECONDED S. Herle, that due to the inability of the Regional Parks Function to fund the grant request to offset property taxes in 2007 along the rail corridor in the Regional District, the Island Corridor Foundation Grant request in the amount of \$109,575, be denied at this time.



PURPOSE

To change the classification of the Morden Colliery Trail from a Community Trail to a Regional Trail.

BACKGROUND

The Regional District currently holds a 20-year license of occupation from the Province of BC over the former Pacific Coal Company railway Right of Way between Morden Colliery Historic Provincial Park and Hemer Provincial Park, located south of Nanaimo within Electoral Area 'A'. The RoW tenure varies in width between 30 feet and 60 feet over its approximate length of 4.5 kilometres, for a total area of 7.35 hectares. The license was issued to the Regional District in 1995 for regional park and hiking trail purposes. In 1998, an additional Park Use Permit was issued to allow the Regional District to develop and manage the section of trail within Morden Colliery Historic Provincial Park. Although the trail license was issued for regional trail and hiking purposes, due to significant local role the trail provides to the area and the infancy of the Regional Parks and Trails System at the time, it has been managed and funded under the Electoral Area 'A' Community Parks Budget. The 2005 Parks and Trails Plan recognized the regional status of the Morden Colliery Trail and recommended that the Trail officially transfer from the Electoral Area 'A' Community Parks Function to the Regional Parks and Trails Function and that it be classified as a Regional Trail.

Currently several portions of the RoW have been developed for public trail, and together make up the Morden Colliery Trail as noted in *Map #1*. Section One of the Trail is developed between Cedar Road and Hemer Provincial Park, where it then joins the Provincial Park's trail system at the west end of Holden Lake. Section Two is developed from Morden Colliery Historic Provincial Park, over Thatcher Creek, and ends at the west bank of the Nanaimo River. As noted on *Map #2*, Section Three is undeveloped and links the east bank of Nanaimo River with Section One at Cedar Road. A major bridge over the river is required to link Sections Two and Three.

A management plan was prepared for the Trail in 1998 by RRL Recreation Resources Limited and in 1999 a feasibility study for constructing pedestrian bridges over the lower portion of the Nanaimo River was conducted by Graeme & Murray Consultants Ltd. Based on two different bridge styles identified in the study, estimates of the capital construction costs ranged from \$444,000 to \$523,000 at the time. The

2007 Five Year Financial Plan currently provides for construction of the bridge in 2013 at an estimated cost of \$600,000. It should be noted that this bridge crossing is for the lower portion of the Nanaimo River. There is also a required crossing further up the river as part of the Trans Canada Trail.

ALTERNATIVES

- 1. That the Morden Colliery Trail be officially classified as a Regional Trail
- 2. That the Morden Colliery Trail remain classified as a Community Trail.

FINANCIAL IMPLICATIONS

- 1. As with the other regional trails that are in the system which includes Arrowsmith, Big Qualicum River, Lighthouse Country, Parksville-Qualicum links, Top Bridge and the Trans Canada Trail, funding is through the Regional Parks Function. The 2005 Parks and Trails Plan recognized the regional and cultural significance of the Morden Colliery Trail and recommended that the Trail be classified as a Regional Trail of which future funding for trail maintenance, development and bridge construction would be through the Region Parks Function.
- 2. Should the Regional Board decide for the Trail to remain classified as a Community Trail, funding for trail maintenance, development and bridge construction would continue through the Electoral Area 'A' Community Parks Function Budget. Continuing with this funding approach would however be inconsistent with the operation and development of the other regional type trails in the system.

CONCLUSION







RDN staff is to gather demographic data on East Wellington and Pleasant Valley along with general information on the cost of developing, operating and maintaining various types of park space and facilities.
