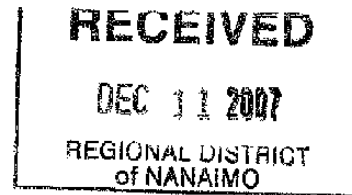

RE: Context for Petition of Public Enquiry into Dec. 4th Cedar Area Flood

38 Families from the Cedar area community including the residents of Wilkinson Rd. , Alice Rd., River Rd. and Aros Rd. signed a petition last night requesting a public inquiry in to the cause of the flood in the area on December 4th. Questions raised at the meeting included an interest in the Dam release records and interest in an assessment of the local culvert system. While most residents expressed gratitude towards the rescue crews and disaster relief initiatives the community is interested in anything that can be done to prevent future disasters of this magnitude. A Channel news was at the local community meeting last night and reported the signing of this petition in the news. They are aware this petition will be filed with City Hall and a copy delivered to the office of MLA, Leonard Krog.
