Thanks, Peter Wilk My initial comments for the 'Board meeting will be to complete my references to the same quotations and timeline that I did not have time for at the COW meeting. It will commence with that portion of the word document starting with the April 9 2013 EAPC motion and will end with his comment on his need for total neutrality on the issue, and my comment on what should have happened if he was really wanted to be neutral. There are no new quotes or information to be verified.

I may add a reference to Director McPherson's comments as reported in the PQ news regarding his continued concerns about Duke Point being a potential site for refuse burning by the city of Vancouver and that duke point is only 29 KM fro his back yard or home. this should be a matter of public record in the minutes of the COW meeting in order to satisfy the validity of his comment.

The second portion of my delegation will be a ledger and on one side will be words that are currently accepted and bylawed in some cases by the RDN. For example., OCP, RGS, embedded portions of the CEEP, CEEP bylaw #______ etc..

In the short time frame given for my response this is the best I can provide at this time considering the normal deadline would be Monday the 24. I hope this is satisfactory to assuage your concerns.

On a final note while I indicated that I would like only a 5 minute time period I would now like to expand that to the normal 10 minute time span.

Re: Seaweed harvesting on the east coast of Vancouver Island

We are contacting you because we are concerned that the commercial harvesting of seaweed in the area of Deep Bay/Bowser on Vancouver Island is proceeding without a satisfactory understanding of the effects of this new fishery on other marine resources and those that rely upon them. This assertion is based on our collective knowledge and scientific experience in the areas of intertidal, foreshore and marine ecology.

It is our view that: (1) the harvesting activities could cause deleterious impacts to the local ecosystem and especially several forage fishes that spawn in the area of the proposed seaweed harvesting, and which constitute a vital part of the food chain for commercial and recreational species such as salmon, lingcod, rockfish and other species, and (2) the seaweed itself, upon decomposing on the beach, contributes significantly to the nourishment of the marine environment which in part supports the economically valuable finfish and the expanding shellfish aquaculture industry – something that we feel no government wishes to put at risk.

The attached document outlines in some detail our scientific concerns and provides our recommendations for consideration by senior governments in addressing any future permitting of seaweed harvesting in this area. The area where seaweed has been harvested lies within the jurisdictional boundaries of the RDN and as such likely constitutes an activity that merits your consideration, especially in relation to its acceptability regarding current and future community requirements and the importance of protecting valuable aquatic resources and their habitat.

We have forwarded our document to Provincial Ministry of Agriculture (the permitting agency for seaweed harvesting) and Federal Department of Fisheries and Oceans (the agency with protection authority for marine resources). In our cover letter to Ministry of Agriculture we have suggested that the process of any future permitting include a meaningful program of public consultation, including contact with local government and the Islands Trust. We have also urged the Ministry to undertake a study of

social impacts, including beach access, noise, lights and altered viewscapes as perceived by neighbouring property owners. We have also forwarded this document to Mr. W. Veenhof, Area H Director.

We would be pleased to meet with you to discuss these issues further.

PURPOSE

To receive the report of the public hearing containing the summary of the minutes and submissions of the public hearing held on June 10, 2013, and further, to consider Bylaw No. 500.383, 2013 for third reading and adoption.

BACKGROUND

Bylaw No. 500.383 (see Attachment 1) was introduced and given first and second reading on May 28, 2013. This was followed by a public hearing held on June 10, 2013. The public hearing minutes and submissions are attached for the Board's consideration (see Attachment 2).

The purpose of the amendment bylaw is to rezone the subject property (See Attachment 3) from Rural 1 Zone (RU1) Subdivision District 'B' to a new Agriculture 1 Zone (AG1) Subdivision District 'B' in order to permit agri-tourism accommodation cabins and a campground in conjunction with an existing farm and farm retail market. The amendment bylaw further includes general amendments introducing new definitions and general regulations for agri-tourism and farm retail sales to recognize the existing farm market and agri-tourism activities on the subject property. If approved, the amendment bylaw would clarify regulation of agri-tourism and farm retail sales on all lands within the ALR that are subject to "Regional District of Nanaimo Land Use and Subdivision Bylaw No. 500, 1987" (Bylaw 500) in a manner consistent with the ALC regulations. There are no conditions to be met prior to adoption of the proposed amendment bylaw and the proposed amendment does not require the approval of the Ministry of Transportation and Infrastructure as the site is located more than 800 metres from a controlled access highway in accordance with Section 52 of the *Transportation Act*.

ALTERNATIVES

1. To receive the report of the public hearing and give third reading to and adopt "Regional District of Nanaimo Land Use and Subdivision Amendment Bylaw No. 500.383, 2013."

2. To receive the report of the public hearing and deny "Regional District of Nanaimo Land Use and Subdivision Amendment Bylaw No. 500.383, 2013.

SUMMARY/CONCLUSIONS

The purpose of Amendment Bylaw No. 500.383, 2013 is to rezone the subject property from Rural 1 Zone (RU1) Subdivision District 'B' to a new Agriculture 1 Zone (AG1) Subdivision District 'B' in order to permit agri-tourism accommodation along with general bylaw amendments pertaining to agri-tourism, agri-tourism accommodation and farm retail sales. The proposal is consistent with the "Regional District of Nanaimo Electoral Area 'H' Official Community Plan Bylaw No. 1335, 2003" policies for resource lands and with Agricultural Area Plan Goal #7 to support agriculture in land use regulations and policies. In addition, the proposed bylaw amendment is consistent with the Board's Strategic Plan priorities and objectives to support sustainable agricultural practices, strengthen the local agricultural economy, and maintain agricultural opportunities that support regional resilience and sustainability. "Regional District of Nanaimo Land Use and Subdivision Amendment Bylaw No. 500.383, 2013" was considered by the Board and given first and second reading on May 28, 2013. The associated public hearing was held on June 10, 2013. Given that there are no conditions of approval and the Bylaw does not require approval from the Ministry of Transportation and Infrastructure prior to adoption, staff recommends that Amendment Bylaw No. 500.383, 2013 be considered for third reading and adoption.

REGIONAL DISTRICT OF NANAIMO

BYLAW NO. 500.383

A Bylaw to Amend "Regional District of Nanaimo Land Use and Subdivision Bylaw No. 500, 1987"

The Board of the Regional District of Nanaimo, in open meeting assembled, enacts as follows:

- A. This Bylaw may be cited as "Regional District of Nanaimo Land Use and Subdivision Amendment Bylaw No. 500.383, 2013".
- B. "Regional District of Nanaimo Land Use and Subdivision Bylaw No. 500, 1987", is hereby amended as follows:
 - 1. Under PART 2, INTERPRETATION, DEFINITIONS by adding the following definitions in alphabetical order:

"agri-tourism means a temporary and seasonal tourist oriented activity or service accessory to an agricultural use that promotes or markets products grown, raised, or processed on land that is classified as a 'farm' under the Assessment Act and in accordance with the Agricultural Land Reserve Use, Subdivision, and Procedure Regulation. Agri-tourism may include but is not limited to farm tours and demonstrations, farm related educational activities, and seasonal promotional events.

agri-tourism accommodation means the provision of temporary and seasonal accommodation accessory to an agricultural use for the travelling public within an agri-tourism accommodation sleeping unit on land that is classified as farm under the *Assessment Act*.

agri-tourism accommodation sleeping unit means a bedroom or other area used as a bedroom for the purpose of agri-tourism accommodation within an agri-tourism accommodation cabin, a tent or recreational vehicle in an agri-tourism accommodation campground or a bedroom within a dwelling unit.

farm retail sales means the sale to the public of products grown or raised on a farm, from that farm and may include the sale of non-farm products in accordance with the Agricultural Land Reserve Use, Subdivision, and Procedure Regulation."

2. Under PART 3 LAND USE REGULATIONS, SECTION 3.3 GENERAL REGULATIONS by adding the following new text after Section 3.3.13:

"14) Farm Use Regulations

On lands located within the Agricultural Land Reserve the following activities are permitted farm uses in accordance with the *Agricultural Land Reserve Use, Subdivision and Procedure Regulation* and are subject to the following regulations:

a) Agri-Tourism

Agri-tourism activities, other than accommodation, are permitted on land located within the Agricultural Land Reserve that is classified as 'farm' under the *BC Assessment Act*, if the use is temporary and seasonal, and promotes or markets farm products grown, raised or processed on the farm.

b) Farm Retail Sales

Farm retail sales is permitted on land located within the Agricultural Land Reserve if:

- i) All of the farm product offered for sale is produced on the farm on which the retail sales are taking place, or
- ii) At least 50% of the retail sales area is limited to the sale of farm products produced on the farm on which the retail sales is taking place and the total area, both indoors and outdoors, used for the retail sales of all products does not exceed 300 m².

15) Agri-Tourism Accommodation

- a) As exceptions to Section 3 of the *Agricultural Land Reserve use, Subdivision and Procedure Regulation*, on parcels within the Agricultural Land Reserve and where agri-tourism accommodation is a permitted accessory use, the following general provisions apply:
 - i) Agri-tourism accommodation use must be for rental only;
 - ii) Agri-tourism accommodation is permitted only on land classified as 'farm' under the BC Assessment Act;
 - iii) A maximum of ten (10) agri-tourism accommodation sleeping units including seasonal campsites, seasonal cabins or short term use of bedrooms within a dwelling unit are permitted in accordance with the *Agricultural Land Commission Act*;
 - iv) The total developed area for an agri-tourism accommodation use, including buildings, landscaping, driveways and parking shall occupy less than five percent (5%) of the total parcel area, in accordance with the *Agricultural Land Commission Act*.

- b) An agri-tourism accommodation campground must be developed in accordance with the following regulations:
 - i) Every campsite shall be unpaved and not exceed 150 m² in area;
 - ii) Washroom and drinking water facilities shall be provided for in accordance with the Vancouver Island Health Authority's regulations and/or provincial regulations;
 - iii) A maximum consecutive or non-consecutive stay of ninety (90) calendar days per visitor within any twelve (12) month period within any campsite on the parcel. The relocation of recreational vehicle (RVs) or campers to other sites within the parcel does not constitute the start of a new stay.
- c) An agri-tourism accommodation cabin must be developed in accordance with the following regulations:
 - i) The maximum gross floor area of an agri-tourism accommodation cabin shall not exceed 50 m²;
 - Washroom and drinking water facilities shall be provided for in accordance with the Vancouver Island Health Authority's regulations and/or provincial regulations;
 - iii) A maximum of one kitchen facility shall be permitted within each agri-tourism accommodation cabin;
 - iv) A maximum consecutive or non-consecutive stay of ninety (90) days per visitor in any twelve (12) month period within any cabin on the parcel. The relocation of a visitor to another cabin within the parcel does not constitute the start of a new stay;
 - v) One (1) parking space per agri-tourism accommodation cabin is required."
- 3. Under PART 3 LAND USE REGULATIONS, Section 3.1 Zones by adding the following zoning classification and corresponding short title after Section 3.4 Regulations for Each Zone:
 - "Agriculture 1 (AG1)"
- 4. By adding Section 3.4.1 (AG1) as shown on Schedule '1' which is attached to and forms part of this Bylaw.
- 5. By rezoning the lands shown on the attached Schedule '2' and legally described as Lot A, Block 360, Newcastle and Alberni Districts, Plan 40890 from Rural 1 (RU1), Subdivision District 'B' to Agriculture 1 (AG1), Subdivision District 'B'

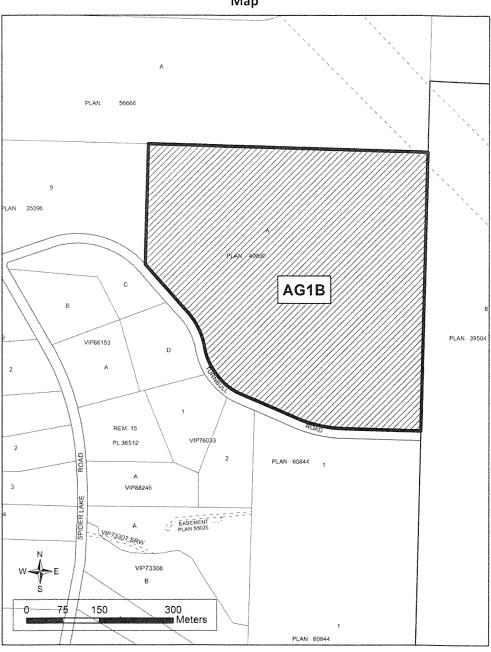

The Chair called for further submissions a third and final time.

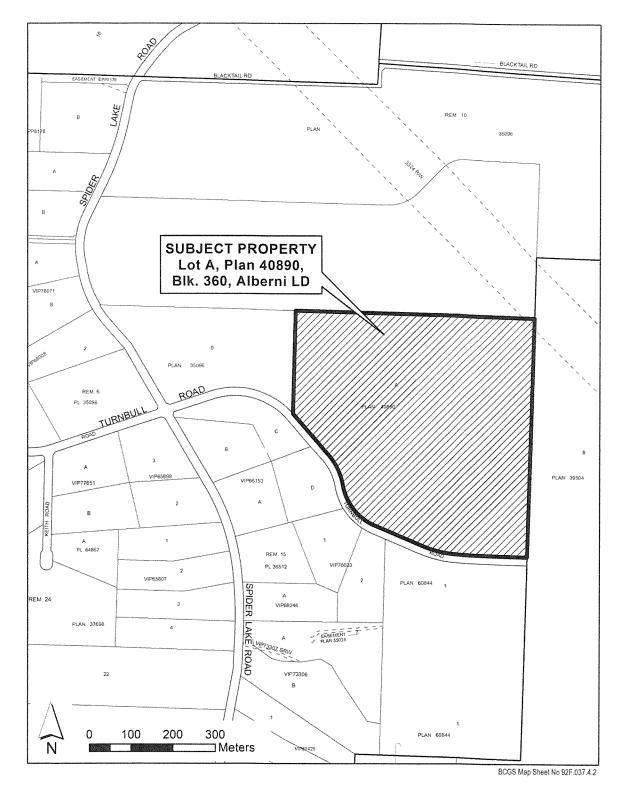
There being no further submissions, the Chair adjourned the hearing at 7:12 pm.

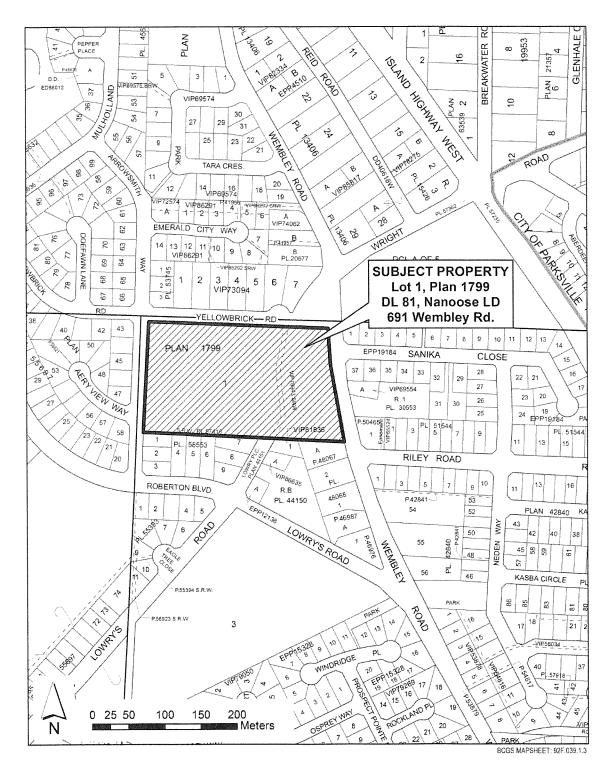

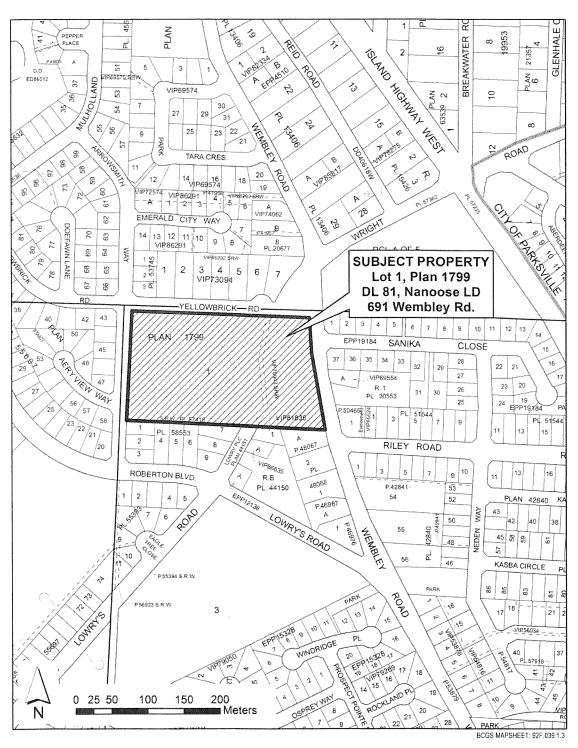

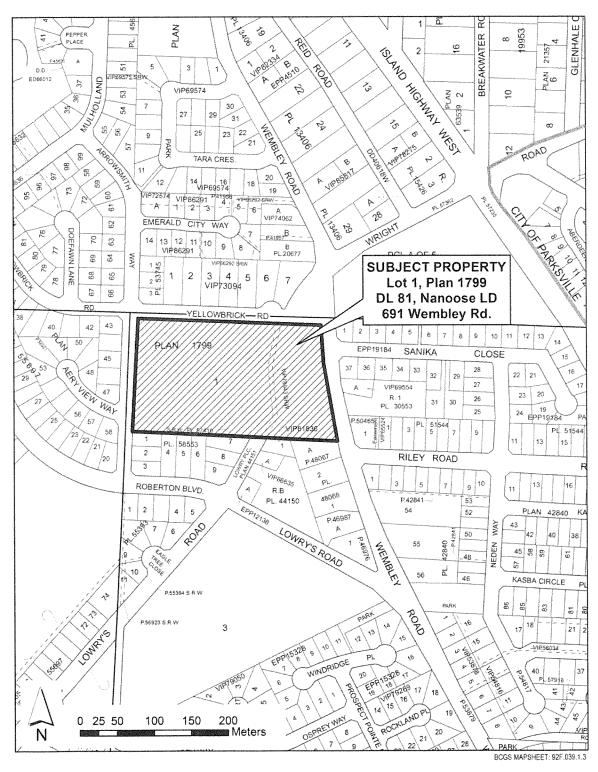

SUBJECT: Reduction of Sewer Development Cost Charges for the proposed Nanaimo Travellers

Lodge Society Not-for-Profit Housing Development at 1917 Northfield Road, Nanaimo

PURPOSE

For the Board to approve a request by the Nanaimo Travellers Lodge Society (NTLS) for a 50% reduction in Regional District of Nanaimo sewer development cost charges (DCCs) for a proposed not-for-profit housing development at 1917 Northfield Road, Nanaimo.

BACKGROUND

Development Cost Charge Reduction

The Regional District of Nanaimo and member municipalities charge DCCs on new development to help cover the capital costs of providing services such as sewer, water, roads and parkland. To incent the development of affordable housing, local governments may reduce DCCs for such projects.

Provincial legislation passed in May 2008 requires that DCC reductions are authorized through a bylaw. In August 2010, the Regional District of Nanaimo adopted *Bylaw No. 1577 "A Bylaw to Reduce Sewer Development Cost Charges for Not-For-Profit Rental Housing"*. Under this bylaw, an eligible development in the Southern Community Sewer Service Area may have the sewer DCCs reduced by 50%.

The City of Nanaimo *Bylaw No. 7082 "A Bylaw to Reduce Development Cost Charges for Not-For-Profit Rental Housing"* is similar to the Regional District of Nanaimo bylaw where an eligible development may obtain a 50% reduction in City of Nanaimo DCCs.

Nanaimo Travellers Lodge Society Application

The NLTS plans to build a new 2-storey building at 1917 Northfield Road and provide 130 beds for long-term dementia care housing. The property is owned by NTLS, a registered not-for-profit society; who will also be operating the proposed new facility. NLTS receives housing subsidies (rent) from the Vancouver Island Health Authority (VIHA) for all residents. VIHA currently pays 73.7% of the housing costs. The remaining 26.3% is paid directly by the residents.

City of Nanaimo DCC Reduction

The City of Nanaimo recently received a request from NTLS, for their property at 1917 Northfield Road, to reduce the City of Nanaimo DCC charge by 50% in accordance with City of Nanaimo Bylaw No. 7082. On May 13, 2013, the City of Nanaimo Council determined that the proposed NLTS development meets the criteria for an eligible development and carried the motion to grant the DCC reduction. On May 27, 2013, the City of Nanaimo Council adopted a Housing Agreement to provide this rate reduction.

Regional District of Nanaimo Sewer DCC Reduction

Based on the information provided, the proposed NLTS development is also eligible for a reduction in Regional District of Nanaimo sewer DCCs according to Bylaw No. 1577.

ALTERNATIVES

- 1. Approve the 50% reduction in Regional District of Nanaimo sewer DCCs for the proposed Nanaimo Travellers Lodge Society not-for-profit housing development at 1917 Northfield Road, Nanaimo.
- Do not approve the 50% reduction in Regional District of Nanaimo sewer DCCs for the proposed Nanaimo Travellers Lodge Society not-for-profit housing development at 1917 Northfield Road, Nanaimo. (Note: the proposed development meets the requirements stipulated in Bylaw No. 1577 for the 50% rate reduction).

FINANCIAL IMPLICATIONS

The proposed NTLS development has a Gross Floor Area (GFA) of approximately 14,136 m², based on floor plans provided to the City of Nanaimo in March 2013 (exact totals will be based on plans submitted to the City of Nanaimo at the Building Permit stage). At the current institutional rate, the total Regional District of Nanaimo sewer DCCs for the project will be approximately \$192,249.60. A 50% reduction would result in a DCC charge of \$96,124.80.

The City of Nanaimo has approved a 50% rate reduction reducing the City of Nanaimo DCCs from \$990,368.16 to \$495,184.08.

The table below summarizes the Regional District of Nanaimo and City of Nanaimo DCCs based on 14,136 m² of GFA:

Development Cost Charges	100% of DCC	50% Reduction
Regional District of Nanaimo sewer charge	\$ 192,249.60	\$ 96,124.80
City of Nanaimo charge	\$ 990,368.16	\$ 495,184.08
Combined Totals	\$ 1,182,617.76	\$ 591,308.88

Exemptions in DCC revenue require that the funding for future capacity comes from elsewhere, typically from increased DCCs for other development categories.

SUMMARY/CONCLUSIONS

The Regional District of Nanaimo has *Bylaw 1577: "A Bylaw to Reduce Sewer Development Cost Charges for Not-For-Profit Rental Housing"* to incent the development of affordable housing. Under this bylaw, an eligible development in the Southern Community Sewer Service Area may have the sewer DCCs reduced by 50%.

The remaining 26.3% is paid directly by the residents. Based on the information provided, the proposed NLTS development is eligible for a reduction in Regional District of Nanaimo sewer DCCs according to Bylaw No. 1577. A 50% DCC reduction would lower the Regional District of Nanaimo sewer DCCs for the proposed development from approximately \$192,249.60 to \$96,124.80.

Re: Local Government Control or Management of Watersheds Request for Meeting

As the representative for the Vancouver Island Water Watch Coalition I am writing to request a formal meeting with yourself and all relevant Ministers within the various portfolios pertaining to drinking water resources, watersheds in their entirety, and forestry lands.

Although most communities in the province have concerns with their drinking water resources and individual watersheds, there is no other area in the province of British Columbia that is in as much jeopardy as Vancouver Island. This extreme vulnerability is traced directly back, and attributable to, the E and N Land Grant.

In 1875 a strip of land, 20 miles wide and stretching from just north of Victoria and upwards to Campbell River, was given away to the coal baron, Robert Dunsmuir for completion of the national railway. This land was given away without thought to either the First Nations or the settlers and with no forethought as to future negative results to the land base and it's life-sustaining resources as the forested lands were parceled off and sold for millions of dollars by Dunsmuir.

To the everlasting shame of the Canadian governments, Dunsmuir and his associates were the only individuals who benefited enormously from this appalling land grab.

Turn the page, flash-forward to 2013, and it is still the First Nations and Island citizens who continue to pay the piper for this narrow strip of land with the ever-growing threat to the Island's water resources due to the privately owned forestry lands.

These privately owned lands continue to be over-logged, poisoned with herbicides and the never ending sell-off of these lands for development, with additional human encroachment, placing stress on watersheds and human drinking water supplies. The Provincial government poorly legislated control equates to the inability of communities to have any positive say or control over their own watersheds. This glaring power inequality has become a major issue of concern for rural and urban communities up and down the Island.

The Vancouver Island Water Watch Coalition was formed in 2005 with Island water resources uppermost in mind as the Coalition strives to educate the public on the essence of life...water.

Most recently we have contacted the Environmental Law Clinic from the University of Victoria, who completed a years worth of work on our behalf as the Coalition attempts to support our communities in understanding what legislation must be changed for the positive, to gain local control of community watersheds and water resources.

In 2011, the Town of Ladysmith had a resolution endorsed unanimously at the UBCM. The resolution reads as follows:

B129 CONTROL OF WATERSHEDS Ladysmith

WHEREAS many local governments draw surface water for their water systems, and such sources are vulnerable to degradation and pollution caused by a variety of industrial and recreational activities;

AND WHEREAS watersheds are not recognized in legislation, leaving local governments without adequate tools to enact measures for the protection of watersheds;

AND WHEREAS many local governments get their drinking water from sources on privately owned land;

AND WHEREAS the provincial health authorities are increasing the requirements for the provision of clean water from local government water systems:

THEREFORE BE IT RESOLVED that UBCM request the provincial government to develop a funding program that facilitates local government acquisition of both the watershed and adjacent land for those local governments with water systems on privately owned land;

AND BE IT FURTHER RESOLVED that all activities in watersheds used for dripking water be

AND BE IT FURTHER RESOLVED that all activities in watersheds used for drinking water be subject to final approval and control by affected local governments and the Ministry of Environment (MOE), and that MOE be legislatively required to ensure that the quality and quantity of water in watersheds meet provincial health requirements.

To date, nothing has been accomplished by this resolution.

In addition, there are many Island watersheds under huge stress, in rural areas water wells are running dry, and there is contamination in aquifers and watersheds at an increasing and alarming rate.

VIWWC cannot emphasize enough how urgent this request is for a meeting with you and all Ministers' involved in these issues. It is imperative that the Coalition share the findings and recommendations of the Environmental Law Clinic plus our own work on behalf of our Island communities.

The Coalition is copying all local governments and MLA's on the Island along so that working together we can reach amicable solutions for all, especially the citizens and their communities who are at Ground Zero with respect to risks in their watersheds.

RE: Wildfire Development Permit Process for the Regional District of Nanaimo

The Regional District Board has utilized funding from the Strategic Wildfire Prevention Initiative for various projects to identify and mitigate wildland urban interface (WUI) fire in the Electoral Areas. Following completion of Community Wildfire Protection Plans (CWPP), I understand that the Board directed staff to prepare a policy implementing several recommendations arising from the CWPPs that would promote public safety. Consideration of a potential Wildfire Development Permit process would build upon the RDN's current proactive approach to the identified top hazard of WUI and aligns with the 2013-2015 Board Strategic Plan, 'Working Together for a Resilient Future'. Wildfire Management Branch of the Ministry of Forests, Lands and Natural Resource Operations, strongly supports this initiative.

British Columbia experiences an average of 2,000 wildfires annually and, although only a small percentage of wildfires are interface, there may be significant impacts on affected communities or associated infrastructure. The impacts to Barrier and Kelowna in 2003 were truly significant events and every fire season, wildfires threaten communities and structures. In 2010 there were approximately 27 wildfires in BC that were significant interface wildfires, resulting in 11 evacuation orders and 16 evacuation alerts. These types of incidents occur throughout the province from the southern interior to the northern interior and include the coast. During the 2009 fire season, "coastal" communities such as Bella Coola were threatened by wildfires and people were evacuated.

As you may be aware, use of wildfire development permits has been recently implemented in the coastal communities of Langford and North Vancouver. In addition, the following local governments have adopted wildfire DPAs to manage interface fire risk (this is not an exhaustive list):

- District of Metchosin
- District of Highlands
- Regional District of Central Okanagan
- District of West Kelowna
- Regional District of East Kootenay
- Capital Regional District
- City of Williams Lake
- City of Prince George
- City of Pitt Meadows
- District of Saanich

The importance of proactive wildfire risk reduction through community wildfire protection planning, fuel management treatments, and the application of "FireSmart" building and infrastructure designs through a wildfire development permit process cannot be overemphasised for prevention of losses to communities. In particular, the wildfire development permitting process is seen as an essential requirement to all new development planning in wildland urban interface areas and the Wildfire Management Branch and the Province fully support initiatives such as this to protect community developments.

From our perspective a good development permit process would include community planning to ensure good emergency egress from more than one road and a separation of properties from the wildland urban interface using a road, park or green space that is managed to reduce wildfire risk from a fuel management perspective. Other important features include use of fire resistant materials in construction and use of fire resistant landscape management options. Finally, a strong wildfire prevention program is key to preventing human caused wildfire starts that account for 50% of the provinces wildfires.

Some other elements of an effective DPA could be identified:

- "Clustered" subdivision design
- Roof-top sprinkler systems for buildings
- Management of fuels through 'Defensible Space'
- A demarcated year-round water supply for fire-fighting and clear access to it
- Clear driveway access to houses, and staging sites throughout the subdivision.

We know that climate change will result in more severe fire seasons in the near future and every effort to reduce wildfire risks to communities in the coming decades will be important.

Wildfire Management Branch would like to congratulate the Regional District of Nanaimo Board of Directors for having the foresight to embark on a process of a Risk analysis, the development of eleven Community Wildfire Protection Plans as far back 2006, several fuels management treatments, and for this new proactive initiative to protect the Regional District from wildfire. Re: Support of a Genetically Engineered Free Zone in the City of North Vancouver

AND THAT this resolution be circulated to the Premier, Prime Minister, all North Shore MLA's and MP's, FCM, and UBCM municipalities."
