SUBJECT: Licence Renewal for portions of the Trans Canada Trail on Island Timberlands Property

PURPOSE

To obtain approval to renew Island Timberlands' non-exclusive licence to use land for the Trans Canada Trail.

BACKGROUND

In 2001, the RDN opened the Trans Canada Trail (TCT), comprised of approximately 30 kilometres of trail, most of which is situated on private forest lands. Licensed public access is provided by both Island Timberlands and TimberWest. A 5-year renewable non-exclusive licence from Island Timberlands (then Weyerhaeuser) was granted to the RDN in 1999 for the purpose of maintaining and managing the Regional Trail for public use. A similar agreement was established with TimberWest.

The Island Timberlands license is for approximately 15.99 km of trail and has been renewed twice since 1999, once in 2004 and again in 2009. As of the end of July 2014, the Island Timberlands licence is up for its third renewal. The company has agreed to a two-year renewal of the original 1999 agreement for a fee of \$500 plus GST. In addition, included within the renewal is the realignment of a portion of trail that will improve accessibility to equestrian users, making the trail useable by hikers, mountain bikers and horseback riders. With little Crown land in the area, the agreements with Island Timberlands and TimberWest are the only options available to provide the TCT.

The TCT is one of the RDN's seven developed regional trails. This well used trail runs from the City of Nanaimo to Extension and then to the Nanaimo River. There is no bridge crossing of the Nanaimo River, however the trail continues from Spruston Road on the south side of the river to the Haslam Creek Suspension Bridge. To the immediate south of the bridge, the TCT continues through the Cowichan Valley Regional District and the Town of Ladysmith.

ALTERNATIVES

- 1. To accept and execute the 2014-2016 licence renewal agreement with Island Timberlands in order to continue operating the Trans Canada Trail.
- 2. To not accept the licence renewal and to provide alternative direction to staff.

FINANCIAL IMPLICATIONS

The cost of renewing the licence for two years (2014 - 2016) is \$500 plus GST and is funded through the Regional Parks Operations Budget. Operations and maintenance of the TCT is carried out by staff and is also funded through the Regional Park Operations budget.

In past, this licence was for a 5-year term with a fee of \$700 or \$140 per year. The new licence is for two years for \$500 or \$250 per year.

STRATEGIC PLAN IMPLICATIONS

The TCT provides outdoor recreation opportunities for hikers, runners, mountain bikers and horse riders. This fits with the strategic goal of ensuring a diversity of parks that meet recreational objectives. The TCT, included in the widely disseminated Regional Parks and Trails Guide, is a good example of a free recreational amenity where citizens and visitors can get out, get active and improve their fitness levels.

SUMMARY

The Trans Canada Trail was inaugurated in 2001 with the conclusion of five-year licence agreements between the RDN and landowners Island Timberlands and TimberWest. The Island Timberlands licence is once again up for renewal and the company has agreed to two years under the terms of the original 1999 licence. The renewal fee is \$500 plus GST.

RECOMMENDATIONS

To accept and execute the 2014 - 2016 licence renewal agreement with Island Timberlands for the purpose of continuing the operation of the Trans Canada Trail.

7.	SECURITY DEPOSIT:	n/a
		The Security Deposit is security for the performance of all obligations by the Licensee under this Licence. If the Licensee defaults in the performance of any obligation herein, WY may, without prejudice to any right or remedy hereunder, apply the said security to the extent necessary.

- 8. TAXES: On demand from WY the Licensee shall pay all taxes associated with the Lands and improvements on the Lands.
- 9. MAINTENANCE AND REPAIR: The Licensee shall keep the Lands and WY roads used in connection therewith in a neat and tidy condition and in a state of repair acceptable to WY, acting reasonably. On termination, the Licensee shall leave the Lands and any WY roads used in a condition acceptable to WY, acting reasonably.
- 10. IMPROVEMENTS: No improvements may be placed on, or physical changes made to, the Lands without the prior written consent of WY. On termination the Licensee shall forthwith remove any improvements placed on the Lands if requested by WY. - b) The Licensee shall use the Lands in a manner to prevent the occurrence of any adverse events and minimize potential hazards that may affect WY and it's contractors, invitees, licensees, employees, agents and servants, the public and the environment; and in connection with any occurrence the Licensee shall implement effective control measures and notify all concerned parties.
- The Lands used by the Licensee shall be subject to environmental audits at the Licensee's cost, as WY, in its sole discretion, thinks advisable.

15. COMPLIANCE WITH LAWS AND REGULATIONS: The Licensee shall comply with all laws, by-laws, and regulations, Federal, Provincial or otherwise.

16. ASSUMPTION OF RISK AND LIABILITY OF LICENSEE:

- a) WY has made no representations or given any warranties save as set forth herein.
- b) The Licensee assumes all risk of damage to property of, or injury including death to the Licensee and the Licensee's contractors, invitees, licensees, employees, agents and servants ("said Licensee") in connection with the exercise of the privileges hereunder.
- c) The Licensee shall pay for all damage resulting directly or indirectly from any act or omission of the said Licensee, whether negligent or otherwise, and shall reimburse WY for all expenses incurred for fighting fire resulting directly or indirectly from said Licensee's acts or omissions hereunder, whether negligent or otherwise.

Such insurance shall be issued by an insurance company acceptable to WY, and shall include an endorsement requiring thirty (30) days notice to WY prior to cancellation. The Licensee shall furnish evidence of the insurance prescribed in sub-paragraphs (a) and (b) above to WY before exercising any privileges granted hereunder.

18. TERMINATION, SUSPENSION AND RENEWAL:

- a) Either party may terminate this Licence by giving the other thirty (30) days notice and if WY terminates this Licence for any reason the
 unearned portion of any prepaid consideration shall be returned to the Licensee, without interest.
- b) If the Licensee defaults, all privileges hereunder terminate ten (10) days after notice of default is given by WY to the Licensee, if the default is not remedied within such time. WY's termination of this Licensee shall not prejudice WY's right to collect damages on account of the Licensee's breach of any term hereof.
- c) Any failure to exercise WY's right to terminate this Licence in case of default does not constitute a waiver of the Licensee's obligations to perform strictly in accordance with the terms of this Licence. Any such right to terminate shall remain in effect and may be exercised as long as the default continues.
- d) The privileges granted under this Licence may be suspended or modified as WY, in it's sole discretion, thinks advisable.
- e) If the Licensee requests a renewal of this Licence at least three (3) months before the Expiry Date, WY may, but is not obligated to, grant a renewal on terms satisfactory to it.
- NON-ASSIGNMENT: Neither this Licence nor the privileges hereunder may be assigned in whole or in part by operation of law or otherwise, without the previous written consent of WY.
- 20. NOTICES: All notices shall be written and deemed duly given if delivered by hand or mailed by registered mail, postage prepaid, addressed to the party concerned at the address herein set forth or at such other address as may from time to time be communicated by notice. Notices shall be deemed to have been received, if delivered by hand, on the day delivered, and, if mailed, on the third day after posting unless there is between the time of mailing and actual receipt a mail strike, slowdown or other dispute which might affect delivery of the mail, in which case notice shall be only effective when actually delivered.
- 21. INTEREST CHARGES: The Licensee agrees to pay WY interest at a rate of 1.5% monthly on any overdue amounts payable under this License.

PURPOSE

To obtain Board approval to direct staff to participate in developing a joint application with City of Parksville, to the New Building Canada Fund, for a financial contribution toward construction of the Englishman River Water System drinking water treatment infrastructure and distribution system.

BACKGROUND

The Englishman River Water System (ERWS) is a joint venture between the City of Parksville (74% interest) and the Regional District of Nanaimo (26% interest) for provision of a regional water supply system. Both partners require improved surface water treatment and additional water intake capacity by 2016 to meet new drinking water standards and demand.

Regional coordination of drinking water provision between the City of Parksville and the RDN has been in place for many years. Drinking water supply to Parksville and Nanoose Bay is currently provided from a combination of ground water wells, and surface water from the Englishman River. In 1999, the Arrowsmith Dam was built through the Arrowsmith Water Service (AWS) partnership between the RDN (Areas E and G), Town of Qualicum Beach and City of Parksville. The dam provides "bulk water" to the Englishman River, ensuring adequate water flows for drinking water needs and protection and enhancement of fisheries.

In 2009, the Englishman River drinking water license was amended by Island Health to require higher levels of treatment by 2016. The ERWS project will meet those requirements, and will provide a reliable source of drinking water to meet current and future needs. The project includes a new river water supply intake, new water treatment plant and distribution system. The project is also investigating the potential of utilizing an aquifer storage and recovery system to balance seasonal water supply and demand and reduce river water extraction. These new initiatives will mitigate our current risks and ensure a safe, secure drinking water source for the next forty years.

The most recent cost estimates for construction of the ERWS water intake, treatment plant and associated distribution system upgrades total approximately \$37 million. Costs will be spread over the period 2015 through 2018 with most of the expenditures expected in 2015 and 2016. The RDN (Nanoose Bay Bulk Water Service Area) portion of the project (including intake, treatment, ASR, and distribution upgrades) is estimated to be approximately \$10 million.

In preparation for seeking voter assent for future borrowing required to fund the project, the City of Parksville and the RDN have approached federal and provincial ministries regarding potential funding assistance for the project. Industry Canada has requested a more detailed submission, which is being prepared in the format of a New Building Canada Fund grant application.

ALTERNATIVES

- 1. Direct staff to participate with the City of Parksville in submission of a New Building Canada Fund grant application.
- Provide alternate direction to staff.

FINANCIAL IMPLICATIONS:

The RDN's contribution to the ERWS joint venture is funded through the Nanoose Bay Bulk Water Service parcel tax. In 2014, this parcel tax is \$310.00 which includes payment towards existing debt for the Arrowsmith Dam and contributions towards the current bulk water project costs. As well, parcels in this area pay a parcel tax for the Nanoose Bay Peninsula water service of \$290 in 2014 for their water distribution system.

Based on the estimated construction costs of \$36,984,494 for the total project with the allocation of an estimated \$10,046,023 to the RDN/Nanoose Bulk Water service, with no senior level government funding attributed to the project, the RDN would have to borrow up to approximately \$7.5 to \$8 million to fund the project. The remainder of the cost would be funded through reserves and development cost charges. This would result in a very preliminary estimated increase to the parcel tax of between \$225 to \$300 per parcel based on the current number of properties and depending on timing of borrowing, interest rates, how fast development occurs and a variety of other factors that could impact the cost of construction, etc.

With senior level grant funding at 2/3 of project costs, RDN borrowing could be reduced to somewhere between \$2.5 to \$3 million again dependent on many factors, which would reduce the estimated parcel tax increase to between \$75 and \$100 per parcel based on the current number of properties in the service.

STRATEGIC PLAN IMPLICATIONS

Provision of a safe, reliable water supply to RDN residents is fundamental to achieving the vision and mission of the Strategic Plan. The joint venture ERWS project supports directly the four strategic priorities of the Plan: Self-Sufficiency (more efficient infrastructure); Economic Vitality (supports development and stability); Regional Collaboration (joint venture with municipalities); and monitoring and adaptation (conservation, protection and enhancement of resources into the future). Pursuing senior government funding opportunities will help to manage the financial burden of this project to the residents of Nanoose Bay Bulk Water Service Area.

In preparation for seeking voter assent for future borrowing required to fund the project, the City of Parksville and the RDN have approached federal and provincial ministries regarding potential funding assistance for the project. Industry Canada has requested a more detailed submission, which is being prepared in the format of a New Building Canada Fund grant application.

The RDN (Nanoose Bay Bulk Water Service Area) portion of the project (including intake, treatment, ASR, and distribution upgrades) is estimated to be approximately \$10 million. The increase to the Bulk Water Parcel Tax, required to fund the project without senior government funding, is estimated to be \$225 to \$300 annually. With 2/3 senior government funding, the increase is expected to be \$75 to \$100 annually.

RECOMMENDATIONS

That the Board direct staff to participate in developing a joint application with City of Parksville, to the New Building Canada Fund, for a financial contribution toward construction of the Englishman River Water System drinking water treatment infrastructure and distribution system.
