Subject: Growth Containment Boundary Amendment by the Town of Qualicum Beach

May 19, 2014

We would like our concerns forwarded to Mr. J. Stanhope and the Sustainability Select Committee for their meeting on May, 20, 2014 please.

In its submission to the RDN for a minor amendment to the RGS, the Town of Qualicum Beach has misrepresented and embellished the actual process undertaken to conduct the required full Official Community Plan review. The Town's process involved only one, poorly advertised meeting for March 4, 2014, entitled a Public Information Meeting, not an OCP Review. Without any further consultation, Council passed first reading of the OCP amendment bylaw on April 7, 2014, followed by second reading on April 14, 2014 and third reading on April 22, 2014. The absence of community involvement has been shameful.

The Town's RGS amendment application certainly is not a minor amendment. It is a regular amendment because the town did not conduct a full OCP review. Other reasons include the following:

- The area involved is totally rural with some 68% of the land still in the ALR and has been preserved as rural through careful planning by the RGS and the ALC.
- The Pheasant Glen proposal effectively bull-dozes and eliminates some 45 acres of mature forest which acts as an ecosystem for a wide variety of animals and birds.
- Upper Beach creek (including its birds and fish) would be threatened as well as the Glengarry lowlands.

The Town submits that its proposal is strictly a "housekeeping and governance issue" but, at the same time, they make constant referrals to the Pheasant Glen proposal. Making hurried concessions to a specific development qualifies as special treatment, not housekeeping and governance issues. The Town maintains that it has no intention of changing the land use by extending the Town boundaries. However, repeated references to Pheasant Glen Resort, which is a high density, illegal subdivision, clearly demonstrates the Town's true motivation for its request to amend the Regional Growth Strategy.

We would respectfully ask that you reject the Town's request for a minor amendment and treat it as a regular amendment so that the residents of Qualicum Beach are able to participate in determining the future direction of their community.

I am writing to protest against the efforts of the Qualicum Beach Town Council to enlarge the town's Growth Containment Boundary. A majority of the Council behave as though they are determined to make this change against the wishes of the town's inhabitants and without honest public consultation. They continually misrepresent, and sometimes even distort, what is said at public meetings. The change they propose looks as if it will be only the beginning of a vast business growth of the town, apparently to bring in much more housing development, higher apartment blocks, and even department stores. The accompanying growth in public services could only result in rising taxes, and for growth most of us do not want. The present Council seems to want Qualicum Beach to become like Parksville, which is only a few miles south of us.

My wife and I moved here from Ottawa last year because we like Qualicum Beach as it is and we had intended to stay here permanently. We hope we shall not have to escape to Victoria. Other towns near here have grown in the way the Council seems to favour and there is no obvious reason why Qualicum Beach should imitate them. This is evidently a retirement community of people who came here, like us, because they enjoy it as it is. Most of them have fixed incomes and some are wealthy – judging by the cars and houses they buy. As a whole, the town is visibly prosperous, with a wide range of banks, shops, and medical and dental offices. We think that only selfish business interests could suggest, as some Council members do, that the town is declining and in need of business growth.

The current proposal before you regarding the extension of the Growth Containment Boundary (GCB) by the Town of Qualicum Beach to match its municipal boundaries is a matter of efficiency and process. Therefore the adjusting the regional growth strategy (RGS), to reflect this, is necessary.

This decision will allow the Town of Qualicum to have the same capabilities of other municipalities in the Regional District. By allowing these changes it will allow Qualicum, as a town, to proceed with decisions made regarding the area outside the present GCB without having to come to the board for approval. This change will be beneficial to both the Regional District and the Town. For the regional district this change means that there would be fewer materials which could be presented to the board. Thereby this move allows more time to be spent on matters which affect the district as a whole or multiple parts. This change in the GCB represents an improvement in the efficiency in the district policy making process for the gain of the entire regional district.

On the side of the town it allows the town it reinforces the democratic principle which the Canadian system is based upon. The council has been duly elected, by the population at large, to make the decisions which are best for the town. As the council had passed the by-law amendment in the April 22nd meeting, their decision and subsequent request should be respected. A failure to do so would be undermining their ability as a council and representative body.

Finally I believe that to avoid making a conflicting decision would be best for all parties. Generally speaking it is the role of the regional districts to act, for issues within municipal boundaries, as a coordinating board between neighbouring electoral areas and municipalities.

A consequence of not following this role was recently been shown through the courts in the case of the GVRD v. The Township of Langley. The Judge's decision on the matter was based upon

"the scope of an RGS is primarily restricted by those matters that require 'coordination between or [that] affects more than one municipality, more than one electoral area or at least one of each, in a regional district. "The change in Langley was not regional in nature and thus it was not subject to the GVRD scrutiny.

This change requested by the town of Qualicum beach is similar to this case due to the fact the request occurs solely within the boundaries of the municipality. Extending the boundary of the GCB to the existing municipal limit does not affect the other parties within the Regional District of Nanaimo and therefore it is not regional in nature. Avoiding a possible lengthy and costly court decision would be best for all. This matter is a municipal issue, and as previously stated the council has made its decision and should be respected as such.

To Committee Members,

The Select Sustainability Committee shall be reviewing the request from the Town of Qualicum Beach to amend the Regional Growth Strategy and preparing a report for the Board of Directors. It occurred to me that one of the main considerations and topics of discussion for the Committee would be how the amendment complies with the intention of the RGS and sustainability principles described in the RGS.

Paul Thompson's memorandum dated May 13th points out that approximately 800 hectares of designated resource, open space, agriculture and rural lands of the Town of Qualicum Beach would be designated urban in the RGS if the amendment is adopted by the Board. From my understanding of the RGS and the meaning of sustainability, this would **not** be considered environmentally and socially sustainable land use planning. I encourage Committee members to review section 3.0 Vision and Sustainability Principles in the RGS.

As an additional consideration, the Town's own Urban Containment Boundary would become vulnerable to expansion as well if this amendment is adopted by the Board. The Town's amendment package includes information about potential land use changes to permit development that would be considered by Council once the GCB is changed.
